Welcome! This is the first of many newsletters that PCN will publish for our active and former participants, employers, and pensioners. With this newsletter we want to keep you informed about what happens at your pension fund, and we will give you useful tips about your pension.

A word from the chairman

After sour comes sweet

A Dutch Prime Minister once said this in the Parliament after a series of painful austerity measures: "After sour comes sweet". I remembered this when I signed the agreement with the Ministry of the Interior and Kingdom Relations last month for strengthening PCN's pension capital.

Things looked a lot gloomier for PCN well over a year ago: pensions were just cut by 3.5% and a new cut of perhaps even 10% was expected for 2018. But just as no one expected it, the US interest rate increased and PCN had an exceptional good year with regard to the return on investments. Together with already implemented measures, among which the cut and the increase of the contribution of the active participants to the maximum limit, PCN achieved a funding ratio of approximately 100% at the end of 2017. This means that the possible reduction for 2018 was no longer needed! Partly due to the extra funding by the government, we can say that the recovery of the funding ratio of more than 20% is a spectacular one. At the same time, this shows how volatile it all can be. An increase – or conversely: a decrease – of the interest rate has an enormous impact on the financial health of PCN. Just as we now profit from the increased interest rate, in the future we might feel the negative effects of a decreasing interest rate again.

The funding ratio of PCN amounts to 112,8% per 31-7-2018. This means that PCN has achieved a funding ratio of over 100% for three consecutive quarters and is no longer in short-term recovery. So even if things get difficult again in the coming years, there will be no new reductions in the short term. Should PCN get in a situation of underfunding again, then we have another period of three years to recover. Even though we cannot make concrete promises, the spectacular recovery of the past months brings the moment of (partial) indexation a lot closer.

Big steps are also taken in other fields. PCN has started to make local investments by investing in the airline company EZ-Air. Other projects are currently discussed.

Local investments

Since 2018 PCN is involved in local investments. Local investments are very important to PCN because by investing locally PCN can give something back to society. For example in terms of employment and accessibility. PCN has invested in aviation, by purchasing two airplanes for EZ-Air. This way PCN tries to contribute to a good accessibility of the BES islands.

New AVO Member wanted

The Advice and Accountability Organ (AVO) was founded in 2014. The AVO consists of three members, one from each island. This year the member from Bonaire will resign.

The trade union, the employers and the UPAH in Bonaire will be asked to nominate candidates. This can be an active, former or retired member. If you are interested in this position you can request the job profile through us, and register with your employer. The AVO member will be given a training.

Update claim

The public employers and Stichting Pensioenfonds Caribisch Nederland (PCN) have agreed upon measures to strengthen the pension fund for the Dutch Caribbean. The most important measure is that the liquidity of the fund is strengthened with a total of 31 million dollar.

The agreement is the result of consultations between PCN and the Ministry of the Interior and Kingdom Relations, as a coordinating ministry on behalf of the government. The legal proceedings that PCN had initiated against the State, have therefore been canceled.
